For the Submission to the People of the Question

Shall the proposed ordinance, a copy of which is reprinted below, be adopted? We, the undersigned voters of the City of South Portland, residing respectively at the South Portland addresses placed opposite our names, hereby petition the City Council to submit the foregoing question to the voters of the City of South Portland.

Secs. 15-175-15-179. — Reserved Ocean Street.

Notwithstanding the foregoing, the section of Ocean Street between "E" Street and "D" Street within the Knightville section of the City shall be one-way traffic with diagonal parking.

Sec. 15-209. Parallel and diagonal parking—required.

Except as otherwise provided in this article, every vehicle stopped or parked upon a roadway where there are adjacent curbs shall be so stopped or parked with the right-hand wheels of such vehicle parallel to and within twelve (12) inches of the right-hand curb, except upon those streets which have been marked or signed for diagonal parking, in which event vehicles shall be parked at a diagonal to the curb indicated by such marks or signs.

Sec. 15-210. — Diagonal parking—

— No vehicle shall stand or be parked diagonally upon any street within the city.
