South Portland City Council Position Paper of the City Manager

Subject:

ORDER #164-13/14 – Award of sole source bid to Hussey Seating, of North Berwick, ME, for the conversion of bleachers in the South Portland Community Center gym. Passage requires majority vote.

Position:

The current bleachers in the gymnasium at the Community Center do not appropriately meet safety standards for participants in events or those watching during times when two courts are used for the event. There have been several injuries related to this issue. Additionally, seating capacity is also limited by the way the floor mounted scoreboard system outlets were installed. The FY CIP included \$50,000 in funding for updates to the gym, pool and teen wing. A portion of this will be used to update the bleachers.

Hussey Seating of North Berwick, ME, originally installed the bleacher system, therefore, the only company that can modify its original work. This item is brought forward as a sole source bid under Section 2-167B.

The work includes removing the exiting support structures to create greater seating capacity on the east and west wall areas, restructure the south wall seating and replace current wooden planks with recycled composite seating. Any supporting parts and wooden seating in good condition will be used at Redbank as needed.

The cost of this work totals \$33,575 and can be completed during the week of August 11th – 16th during the Community Centers annual shut-down.

Included is a memorandum from Rick Towle regarding this item. He will be at Monday's meeting to answer any questions.

Re: SPCC Bleacher Update

During the FY 15 budget process the Department recommended for safety reasons to update the bleacher system inside the SPCC gymnasium. Appropriated through the generosity of the City Council as part of the budget for this project \$50,000 was placed in account number 407765-651800-15771. Please find attached in the supporting information a sole source bid for the work due to the only company who can modify their original work is Hussey Seating of North Berwick, Maine. Work and materials totaling \$33,575.00 is to be performed by Hussey during the week of August 11-16th, 2014 pending City Council approval.

The scope of this update includes removal of existing support structures to make greater capacity for seating on the East and West wall areas of the gymnasium, restructuring the South wall seating for safe use by the public, and recycled composite seating in the color of blue replacing the current wooden planks that were originally specified by the architect. All supporting parts as well as wooden seating to be removed will be remain the property of the City as we have a similar system in Redbank that the parts should fit to lengthen the life of that system.


